Koch Industries, based in Wichita but with a large tax department in Atlanta, completed its acquisition of Infor Global Solutions, a leading enterprise software developer in Atlanta ... Cott Beverages in Tampa acquired Primo (bottled water) and changed its corporate name to Primo Water Corporation ... Cree, Inc. (semiconductors) in Durham spun off its power and RF businesses into a new company called Wolfspeed ... Microsoft acquired land in midtown Atlanta to build a corporate campus and began hiring tax professionals on a remote basis ... 21st Center Oncology (cancer treatment centers) in Ft. Myers, Florida was acquired by GenesisCare, based in Australia.
